LINCOLNVILLE BEACH Well placed along the two path, three path around, challenged three across and edged clear. BAYOU MELODY Vied inside, drifted in at the half mile pole bothering LADY QUINN, continued matching strides along the rail and finished well. THIN LEGS Vied along the two path, between at the furlong marker and weakened. IN TRAFFIC Unhurried along the three path, two path around and was not threat. JACKSON AVENUE Four wide on the turn, was not a factor. LATEST EDITION Two path into the turn, three path out of it and tired. RUBYS MISSION Three path on the bend, was outrun. LADY QUINN Appeared in tight at the half mile pole, took up, saved ground and tired. A claim of foul was lodged by the rider of LADY QUINN against BAYOU MELODY for interference at the half mile pole, was not allowed.
