EVANDERKEEN Close up four wide early, three path after that, four wide into the lane, responded and bested REAL ELEVE on the wire. REAL ELEVE Tracked along the rail, eased out into the lane, quickly took command, began to drift out under left handed pressure and missed. STJAMES Saved ground, checked into the backstretch, unhurried along the three path, took the rail into the lane, eased out and made a late bid. REDOUBTABLERIPKEN Stumbled at the start, unhurried two from the rail, four wide into the lane and finished with interest. JOHN THE BAPTIST Set the pace along the two path, was hooked in upper and tired. PURE REALIZATION Unhurried, saved ground to midway on the last turn, two path into the lane and tired.
