BREAK THE FALL Tracked along the two path after a half to the top of the lane, responded when asked and asked wore down PERCY for the score. PERCY Away well, set the pace along the two path, saved ground on the last turn, was hooked a sixteenths out and just missed inside. VIKING WARRIOR Unhurried along the rail, eased out into the lane, drifted out two times bumping SKELLIG ISLAND through the stretch and bested that one for a share. SKELLIG ISLAND In hand along the two path, took the rail into the last turn, angled out into the lane, was bumped two times by VIKING WARRIOR through the stretch and missed the show. DANCINWITHJAKE In hand four wide, lodged a bid five wide into the lane and flattened out. DR. DARBY Broke slow, lagged back while never in it. ONE WITHEVERYTHING Tracked along the three path to the last turn and tired. EIGHT SUNSET DRIVE Broke out at the three-quarter pole, took hold, five wide on the last turn and tired. UNITY DREAMS Three path into the backstretch, saved ground after that and tired inside. A Stewards inquiry along with a claim of foul by the rider of SKELLIG ISLAND against VIKIING WARRIOR for causing interference two times in the stretch, resulted in the disqualification of VIKING WARRIOR from third to fourth.
