BROCKMONINOFF Hopped the start, vied along the two path, took charge and then drifted out through the stretch. BAY BANK Close up along the three path, four wide into the lane and made late bid. INVALUABLE WILL Well placed four wide, challenged at the furlong and then drifted out to the wire. MISTER J T Four wide, five wide into the lane and failed to threaten. BUSTING CREDIT Two path early, three path around and tired.
