FINALIST Showed the way along the three path, two path around, responded and was ridden out. CASCADE CRUISER In hand six wide, four wide into the last turn, tracked into the lane and finished well. GOLDINI Unhurried along the two path, stayed that path into the lane and was going well at the end. DRINKING SOLO Tracked along the rail and tired on that path. RINGGOOD Four wide early, six wide late and finished wide. DON ANTONIO Tracked four wide to the final turn, three path around that one and tired. COLTEN GOES Close up five wide, three path into the last turn and five wide out of it. RECKLESS PLACE Two path on the turns while always outrun.
