REDHOTNOTBOTHERED Set the pace along the two path while pressed, took the rail around, shook clear, was soon collared, battled on and finished gamely inside. MAGIC BEACH Forced the issue along the three path, tracked into the lane and weakened. PROBABLY FLATTERY Well placed along the two path, took the rail around and failed to fire. AMERICAN LITIGATOR Five wide early, four wide entering the bend, five wide leaving it and failed to threaten. A FEW CHOICE WORDS Broke slow, lagged back along the rail while outrun. RENAISSANCE MAN Two path early, four wide into the lane and tired.
