RINGGOOD Unhurried along the three path, stayed on that path into the lane and made a late bid. UTAMARO Unhurried five wide early, stayed wide on the last turn and failed to rally. SOX FOR DAUGHTERS Lagged back, three path on the turns, angled out and passed faders. GANDY DANCING Close up five wide early, tracked three from the rail on the final turn and tired. AMERICA'S JUSTICE Well placed four wide early, three path after that and tired. MAJESTIC FRONTIER Saved ground to the last turn, three path into the lane and failed to take part. CO CONSPIRATOR Close up along the two path, six wide into the lane and tired. DRINKING SOLO Vied for the lead along the rail and tired.
