NILRUC Broke slow, five wide on the first turn, two path around the last one, launched a bid inside, took the advantage appearing to clear while drifting out, bothered ENTICING PROSPECT and was going away at the end. VIKING WARRIOR Broke sluggishly, five wide early, four wide into the lane and finished well. MAJESTIC FRONTIER Forced the issue five wide, three path after a half to the lane, battled and weakened late. ENTICING PROSPECT Set the pace four wide while pressed, two path on the last turn, battled and then took up when the winner drifted out missing the show. UTAMARO Well place saving ground and weakened. RINGGOOD Saved ground throughout, was outrun. DOROTHYS HAPPINESS Three path on the turns and tired. A claim of foul was lodged by the rider of ENTICING PROSPECT against the winner for interference in the late stages, resulted in the disqualification of NILRUC from first to fourth.
