WHILE I vied for the lead while inside then drew away going into the far turn, was all out in the final strides and held sway in the last jump. WEST COAST COWBOY vied for the lead while two wide until the far turn, dropped back then came again in deep stretch and lost the head bob on the wire. COUNTY JUDGE was unhurried early on then rallied on the far turn, was gaining ground but was no menace. HEY vied for the lead while three wide until the far turn then was used up and gave way. FINE TUNED stalked the early pace while inside, was used up then gave way going into the far turn. This race was re-timed using video technology to arrive at the most accurate time.
