HOLLYWOOD ICON set the pace along the rail under mild pressure from SPOONS, shook clear of that rival nearing the eighth pole, then held off a late challenge along the inside. GOOD PRODUCT was the trailer into the clubhouse turn, advanced to track behind the pace along the inside, made a good run up the rail at the eventual winner, but came up short. SPOONIE pressed the pace two-wide then gave way at the top of the stretch. MORTIFY tracked three-wide early on, weakened midway down the backstretch, and failed to menace. COUNTY JUDGE went four-wide on the clubhouse turn, continued to the far turn, drifted out of the path entering the stretch, and did not offer a rally. FINE TUNED chased throughout, no factor. This race was re-timed using video technology to arrive at the most accurate time.
