TAPITURE'S LADY settled off the early going, asked through the far turn, raced four wide into the upper stretch and surged up late under strong handling. LADY MAZATLAN stalked the pace, challenged near the three sixteenths pole, led inside the sixteenth pole and missed in a game effort. FAST N BREEZY showed good early speed to set the pace along the inside and gave way grudgingly late. TELLITTOTHEJUDGE made a four wide bid and needed more in the drive. GOLDIES CLAIM urged from the inside and weakened. ADETERMINEDMOM up close early and faded. This race was originally hand timed and was re-timed using video technology to arrive at the most accurate final time available.
