TIME MACHINE was on the pace outside JABRAN through the opening half, was joined by MY UNCLE LEON midway of the far turn, dueled that one through the lane and dug in late to narrowly get the nod. MY UNCLE LEON stalked the leaders three or four wide to launch his bid in the far turn, floated wide into the lane while showing in front5, dueled the winner and narrowly missed late. NUMERO SIETE stalked the pace three or four wide to move up into the lane but could not get to the top pair. BLOW TORCH was three wide and failed to offer a solid late bid. JABRAN contested the lead inside the winner to the far turn and weakened. ANGEL'S MAGIC was not a factor. This race was originally hand timed and was re-timed using video technology to arrive at the most accurate times available.
