FLASHIN CHIP tracked the early leader three wide to bid into the lane and went clear under steady handling. DORIS AVENUE showed the most early speed about the two path then could not go with the winner in the lane. OTTER CREEK came four wide into the lane and improved position but could not get to the top pair. LORD HENNESSY was two to three wide and lacked a final closing run. PAPA'S NICO BOY failed to mount a rally four wide. PURE CRYSTAL trailed from along the inside. This race was originally hand timed and was re-timed using video technology to arrive at the most accurate times available. The three-eighths fraction was unavailable due to a timer malfunction.
