SARAH'S COURT tracked the pace outside GRACIE'S A TIGER, bid into the lane and wore that one down to score late. GRACIE'S A TIGER made the pace out from the rail, resisted the winner but was worn down through the final sixteenth. PONDICHERRY stalked the pace three or four wide and continued well in the lane to bid but fell short. MY MAYBELENNE moved up four wide going to the far turn then made a mild gain in the stretch. YOU HAVE NO IDEA saved ground and lacked a solid closing bid. UTSIRA was not a threat three wide, pulled up after the race and was taken off by equine ambulance. BAYLEYWICK stalked the pace along the inside and failed to produce a bid. ROCKIN MARIE dropped out early four wide. This race had a timing discrepancy and was retimed using video technology to arrive at the most accurate times.
