ULTIMATE forced the pace outside a rival to bid into the far turn, dueled the remainder and gamely prevailed late. SILVER SCREEN was on the pace off the rail, dueled the winner through the far turn into the lane and continued gamely to narrowly miss. WEST ISLAND was four and five wide early, bid four wide going to the far turn but could not produce the needed late effort. OREGON COUNTY stalked the pace along the inside and lacked a final closing bid. TO TOO TWENTYTWO moved up inside but could not threaten late. PICCATATA PRINCE was not a threat three and four wide. PROMISE CODE failed to mount a bid three wide. TOUGH AS AN OX dropped back early. This race was originally hand timed and was re-timed using video technology to arrive at the most accurate times available.
