CALL ME DROSSEL was taken wide, set the pace, was under pressure late and held well. SOMNUS vied inside early, dropped back to chase the pace, bid willingly to contend and was outfinished in a good effort. SEVERANCE veered out at the start, trailed the field, found his best stride late, was gaining ground and got up for show. AFTER MY BROTHER raced mid pack, saved ground, closed steadily and didn't have enough late. SMILE LIKE KYLE was never far back, lacked the needed late response and failed to menace. ALVIN lagged early, failed to respond and was not a threat.
