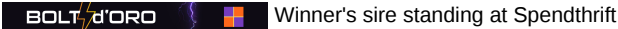

CHRYSO ALOGO shifted in soon after the start, pressed the early pace inside taking a narrow lead at the half, faced first one then another challenger from outside, dueled in the stretch and dug in to edge away late. LUNDBERG was bumped hard at the start, tapped on the brakes ever so slightly past the gap, switched out and advanced four wide early on the turn making a bid at the five-sixteenths, dueled through the stretch but was denied. EXCELLENT EMPIRE bumped a rival hard at the start, settled into stride switching out and advancing between foes at the half, continued near but off the fence and gained steadily in the stretch. SHADOWLESS bumped with the outside foe twice at the start, made an early advance to press outside heading into the turn, contended between foes at the three-eighths, steadily dropped back and faded. RIVER RIDGE exchanged bumps after the start, raced four wide on the turn and off the pace, failed to rally. BILDERBERG chased briefly, dropped back inside foes and faded. SMOOTH N SILKY settled at the rear, swung wide for the drive, was left with too much to do and failed to menace. HE GONE had a narrow early lead outside the eventual winner, steadily retreated from the seven-sixteenths shifting in and faded. FOLLOWING AN OBJECTION BY THE RIDER OF LUNDBERG AGAINST CHRYSO ALOGO ALLEGING INTERFERENCE NO ACITON WAS TAKEN.
