## Footnotes | View Glossary Of Terms

LAST GASP showed the way in the two path turning up the backstretch, drew clear under a nudge around the far turn, was cued at the top of the lane, kicked on while drifting out thru the lane, and held clear. MAYLEN tracked along the rail, was roused in the two path passing the three-eighths pole, angled out to the five path at the top of the stretch, drifted out down the stretch, but ran on to clearly be second best. MISS KITTY PIE raced off the pace in the four path, was driven around the far turn, floated out to the five path at the top of the lane, and finished evenly to get up for show. LUTION chased in the four path, was ridden in the three path around the far turn, but flattened in the stretch. SOME OF IT laid up close in the three path but backed up around the far turn.
