REXFORD disputed the pace with COMMITTEE OF ONE and GOODASIWONSWAS racing three-wide, took the lead nearing the eighth pole and edged clear late. COMMITTEE OF ONE vied for the lead from along the inside, came out to bump GOODASIWONSWAS nearing the sixteenth pole, then continued to come out and hele on well for the place. GOODASIWONSWAS vied for the lead through out from between horses, was bumped and carried out by COMMITTEE OF ONE nearing the stretch pole and finished well in a good effort. CHRYSO ALOGO was allowed to settle, angled out to be four-wide nearing the quarter pole and weakened during the drive. JOURNEY dropped back while racing five-wide on the turn and trailed. THE RIDER OF GOODASIWONSWAS LODGED AN OBJECTION AGAINST BOTH REXFORD AND COMMITTEE OF ONE AND AFTER VIEWING THE FILMS THE STEWARDS RULED THAT COMMITTEE OF ONE CAUSED INTERFERENCE AND DISQUALIFED THAT ONE FROM SECOND AND PLACED HIM THIRD.
