KIYOMORI raced midpack, bid before the 17th of 18 fences, jumped the final in tandem with EVIE'S PRINCE, landed first, and raced all out for the win. EVIE'S PRINCE kept pace with the leaders, assumed command after the 16th fence, jumped the final with KIYOMORI, and just missed at the wire. AUCTION KINGDOM rated early, increased speed after the 16th fence to pass rivals and held third place to the finish. MINELLA PLUS (IRE) raced midfield, lost ground before the 13th fence, then passed tiring rivals before the final. COURT DUNN (IRE) rated, gained ground before the 13th, flattened, tired and pulled up before the final and walked off. LIGHTNING RIDGE led the field through 16 fences, tired and pulled up before the final and walked off. WHEN U KNOW trailed, tired and pulled up before the 14th fence and walked off.
