RING RIGHTS broke slowly, raced well back four wide, closed outside through the stretch and was up late. VEKOMA VIEW raced in range inside, dropped back inside around the far turn, split rivals near the quarter pole, rallied inside, took the lead leaving the eighth pole but could not withstand the winner in the later yards. JUST IN TOUCH hesitated at the start, trailed two and three wide, swung widest in upper stretch and closed well to gain the show late. BESIDE YOU settled in range three wide, advanced four wide around the far turn, had aim in upper stretch and flattened out. COPYCAT pressed the pace two wide, took the lead near the five-sixteenths marker, led past the eighth pole and weakened. SHE REIGNS stumbled badly at the start, raced three wide and never threatened. POINTILLISM (GB) tracked the pace three and four wide, bid nearing the quarter pole, continued on the left lead in the lane and tired. SMITTEN failed to menace while racing three wide. TIME FOR YOU set the pace along the rail and retreated after six furlongs. SAILS UP was outrun inside and was eased through the lane. CHOCOLATECROISSANT (IRE) hesitated at the start, made little impact and was eased through the lane.

SWEET SASH pressed the pace three wide, took the lead turning for home and drew clear under confident handling. GAME ENERGY was bumped at the start, dueled two wide between foes to midstretch and dug in to hold the place. LIKELY PERSPECTIVE (IRE) dueled at the rail to midstretch, could not keep pace with the winner but kept on top hold the show. MITHRIL bumped with PERFECT SHANCES early, chased the pace inside, steadied nearing the turn, chased two wide around the bend, angled four wide in upper stretch and was one-paced through the lane. NEBLINA bumped with PERFECT SHANCES early, raced three wide and went evenly. PERFECT SHANCES had her head turned at the start, was bumped on both sides early, checked nearing the turn and had no further bids. MY SWEET ADALINE broke out and bumped hard at the start then trailed in the two path.

TUT'S REVENGE broke a tad outwardly at the break, then went up to show the way while off the rail and under a good hold, raced in the two path on the turn while being well handled, then was engaged nearing the quarter pole by BROTHER BRAD, came off the turn three to four wide and had a long drive with that rival but held gamely to prevail. BROTHER BRAD stalked the pace and made a three wide bid nearing the quarter pole and had a long drive with the winner but was out-gamed and had to settle for being second best. MR SCATTER was settled early and advanced three to four wide on the turn but lacked the needed rally while besting the rest. BLUE SLIDE PARK tracked the pace along the rail and weakened midway on the turn and then tired. DOWNING STREET was off slowly and trailed on the inside, saved ground on the turn and failed to menace.
