RUNNING ON TIME prompted the pace on the outside and went up to press the pace on the far turn in hand, then took over when ready nearing the quarter pole and drew off to prove much the best while being show the crop but proved best under hand urging. OFF THE DECK set the pace on the inside and then was pressured by the winner on the far turn and proved to be no match for that rival the final quarter of a mile while staying on to be second best. RUDI was allowed to settle two wide, then advanced two to three wide on the far turn and came four wide off the bend and lacked the needed bib while besting the rest. ANTONINO angled in entering the first turn to be reserved three to two wide, two wide by the quarter pole and passed the tiring rivals. AU NATUREL was allowed to settle on the inside, two to three wide on the far turn and had no rally. KY'S LAW was four wide on the first turn and chased the pace four to three wide and tired. LITTLE BIG MAN tracked the pace in between rivals but tired. TENNESSEE WALTZ was off very slowly, raced on the inside and never factored. SWEET INTERLUDE tracked the pace on the inside and weakened on the far turn then stopped.
