GLANCING MY WAY saved ground in range, closed along the rail in the stretch, took the lead leaving the sixteenth pole, drifted out and just lasted. KATE THE SMATE was off slowly, raced two wide in midpack, swung five wide in upper stretch, rallied outside and just missed. FERMI broke outwardly and bumped at the start, chased the pace two and three wide, rallied between foes and was just up for the show. GIGI CAKE'S set a pressured pace in the two path, kicked clear in midstretch, led past the sixteenth pole and weakened late. DOLCE VINO was pinched back at the start, trailed inside, swung out in upper stretch and rallied belatedly on the left lead. ROGUE RUNNER broke in and bumped WINROOSKI at the start, came out soon after and bumped NACHO PROBLEM into ZEALOT, chased the pace three and four wide and was one-paced through the lane. WINROOSKI was bumped at the start, pressed the pace in the three path and tired in the final furlong. LUCKY ESTHER was outrun while racing two wide. NACHO PROBLEM was pinballed at the start, raced three wide and never threatened. ZEALOT was bumped soon after the start, raced four wide and was through early.
