ANTONINO raced in range three wide, took over in upper stretch and drew clear under a drive. DAVID PEPPERMAN saved ground off the pace, went two wide between foes around the far turn and rallied for the place. APACHE ONE SIX raced up close inside, rated back down the backstretch, made progress inside around the far turn but was one-paced through the lane. SUPREME HONOR bumped with TYBEE ECHO at the start, raced well back two wide, raced four wide around the far turn and had a mild rally. TYBEE ECHO bumped at the start, chased the pace two wide, checked leaving the five-eighths marker, saved ground around the far turn and ran on through the stretch. THREE CHEERS raced off the pace pace two wide, made progress four wide around the far turn but faded in the lane. SMASH CITY raced up close inside, swung out in upper stretch and weakened. I WANNA BE ME was off slowly, rushed up four wide around the first turn, pressed two wide under a hard hold down the backstretch, took the lead two wide nearing the quarter pole and came up empty in the lane. SWEDISH CANDY moved three wide to the lead early on the first turn, briefly cleared and angled in early on the backstretch, vied inside around the far turn and tired in the drive. NOAH'S HONOR had only brief speed three wide.

If I CAN DREAM was allowed to settle early on the inside, eased off the inside and made a five wide bid leaving the turn and went on even terms with his barn mate by the furlong marker and drove clear in the furlong grounds to prove best. REBELLUTION broke a bit flat footed and then had outside pursuit, made a five wide move on the turn and then hit the front nearing the quarter pole and moved in to be four wide off the bend and then was headed by the winner by the eighth pole and was out-finished and had to settle for being second best. TURBO FIRE was well placed early on the inside, shuffled back by the five sixteenths and then moved off the inside and swung out six wide leaving the turn and made a bid but needed more in the final furlong while besting the rest. VEKOMA VELOCITY pressed the pace three wide and made a three to two wide bid on the turn to vie for command to nearing the quarter pole then weakened in the drive. IL PRINCIPADO showed good early speed on the inside and fell back leaving the three eighths marker, moved out leaving the five sixteenths and came three wide into the lane while weakening. TRAVIESO was off slowly and outrun early, came five wide into the lane while being no factor. DON'T GO ASTRAY stalked the pace four wide and then made a three wide bid on the turn to vie for command between rivals leaving the five sixteenths marker but came up empty in the drive. ROUX BUCHERRO was bumped at the break, chased the pace two wide and then was empty in the drive.

DRUM ROLL set the pace along the rail, was collared leaving the quarter pole and kept on well enough to hold the place. WORLD TRAVELER saved ground off the pace, angled three wide turning for home and was one-paced through the lane to gain the show. MORE THAN GLORY saved ground and never threatened.
