BREEZER stalked the pace in the four path, bid in upper stretch, vied outside of MAITRE D to the wire and narrowly prevailed. MAITRE D dueled outside of MENSA in the three path, put that foe away in upper stretch, was quickly confronted by the winner, battled inside to the wire and just missed in a game try. BEAUTY BOLT raced off the pace three wide, shifted wider in upper stretch and finished strongly. MACKOR raced in range three wide, bid inside of foes in the stretch but was outkicked late. IMAPEPPA raced well back two wide and rallied belatedly. PRINCE DAVID lacked early speed, raced three and four wide and was gaining late. VALID SENSE saved ground to no avail. CAJUN'S COOKIN chased the pace two and three wide and lacked a closing bid. ANTILLEAN was outrun inside. WILD WEST JUSTICE played no factor while racing two wide. MENSA dueled inside a foe in the two path and wilted in the lane. KING JULIEN saved ground and made little impact.

CAJUN GOLD set the pace in the two path, drifted out under left-handed urging in the lane and dug in late to just last. MELODY MAN raced off the pace two wide, angled four wide in upper stretch, rallied between foes and just missed. MAN WITH THE MONEY prompted the winner in three path, battled on between foes through the stretch and just missed. KRAKEN bumped hard at the start, raced well back three wide, swung five wide in upper stretch and rallied widest. NIGHT raced in range inside and was one-paced through the lane. DEEP DUSK had early speed inside, steadied into the turn and was no threat from there. EVIL EMPIRE bumped hard at the start, raced far back inside and was no threat. STEP SLOW was pinched back and taken up at the start and never reached contention.
