TAM TAM stalked the pace in the three path, took the lead in upper stretch and edged ahead under a drive. EAT HAY RUN tracked the pace from the rail, bid inside of the pacesetter in upper stretch, vied inside of the winner through the final furlong and was narrowly outfinished. LEGAL SQUEEZE settled off the pace while racing two wide and rallied for the show. CLASSIC MOVE set the pace in the two path, was confronted on both sides in upper stretch and weakened. ENJOYING raced well back two to four wide and improved position in the lane. CONQUERING MARIN (IRE) raced off the pace three wide, was pulling around the first turn, continued three wide around the far turn and never threatened. JUSTIFIED GIFT was reluctant to load, raced off the pace inside and never threatened. CANDY ROCKETTE was reluctant to load, was unruly in the gate, hesitated at the start, trailed inside early, went three wide around the far turn and showed some late interest. ELECTA was outrun while racing two and three wide. DEVILISH GRIN played no factor while racing two and three wide. SONNYNPEACHES raced up close four wide and faded in the drive. POINT IN TIME chased the pace three wide and had no response when roused entering the far turn.

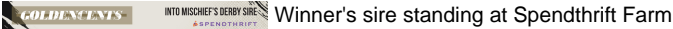

MR SCATTER raced off the pace inside, swung six wide in upper stretch, surged outside and was up and clear late. LOU THE BODY bumped at the start, raced in range inside, angled to the four path near the five-sixteenths marker, bid between foes, took the lead near the sixteenth pole but was no match for the winner late. BOLD ADVANCE disputed the pace inside of BLESS AMERICA in the two path, led to the sixteenth marker and weakened. BLUE SLIDE PARK chased the pace in the four path and was one-paced through the lane, after the race was vetted on track and loaded on to the equine ambulance.. BLESS AMERICA vied in the three path and tired in the drive. WILL OF A WARRIOR bumped at the start and was outrun while racing well off the rail. This race was originally hand-timed and was re-timed using video technology to arrive at the most accurate times.

LAIGINA pressed the pace in the three path, drew clear nearing the far turn, widened while still well off the rail around the far turn, drifted out a bit in the lane and extended the advantage under mild urging. BAYOU BRIGID bumped with BRAT GIRL not long after the start, raced in range two wide while keyed up, bid between foes midway down the backstretch, could not match strides with the winner entering the far turn, chased in the two path around that bend and kept on well in the lane to hold the place. BRAT GIRL bumped and steadied not long after the start, raced off the pace two wide, angled four wide early on the far turn and ran on for the show. TIMEFORPEACE chased the pace three wide and lacked the needed rally. VITA MIA raced in range inside and faded after a half. BEWARE OF OOH LALA set the pace in the two path, could not keep pace with the winner nearing the far turn, chased inside around that bend and came up empty in the lane. COVERED IN CRYSTAL bore out entering the first turn, was pulled up and walked off.

DANDONA bumped with MEILANI at the start, trailed inside early, moved up four wide around the far turn and finished well to gain the show late. CALL ME PRECIOUS raced in range four wide and was one-paced through the lane. VIVA VIENNE checked midway around the first turn, fought rating repeatedly, rushed up outside down the backstretch, bid between foes around the far turn and faded through the final furlong. MEILANI bumped at the start, raced in range two and three wide, steadied midway down the backstretch and lacked the needed rally. REINA DEL VIENTO failed to menace while racing two wide. JUST A MINUTE pressed the pace two wide and faded after a half. HUMOR ME BABY had only brief speed inside.

SLIPPERS checked midway around the first turn raced four and five wide and never threatened.
