I LOVE GIRAFFES saved ground off the pace, rallied along the rail, took over leaving the eighth pole and held safe under a drive. DELIGHTFUL DARLING tracked the pace two wide, bid outside of the pacesetter in midstretch but was outranked by the winner late. BENEFICENCE raced off the pace three and four wide and rallied through the lane to gain the show. IGNIS COR lacked speed while racing two wide and rallied belatedly along the rail. R P BYRNE (IRE) set the pace along the rail, drifted out in upper stretch, led past the eighth pole and weakened. PEARL OF PEARL was off slow, saved ground off the pace, tipped out in upper stretch and never threatened. QUEEN JUNO failed to menace while racing two wide. AUTHENTIC CHANCE chased the pace three wide and faded in the lane. FLEETING MOON played no factor while racing four wide. EPIC PRANKSTER was outrun while racing two wide.

MAKTUB was settled early on the outside, made a four to five wide move on the far turn to loom boldly off the turn and drifted out by the sixteenth marker while drawing clear to prove best, driving. WARRIOR WAYNE set the pace while in the two path, then was pressured nearing the half mile marker and on the far turn, shook clear leaving the quarter pole but could not fend off the winner in the furlong grounds while keeping on to be second best. WANNABEELOVED prompted the pace and then pressured the pace three wide but faded in the final furlong while staying on to best the rest. INTERNAL CAPITAL bumped with a rival at the break, settled between rivals on the first turn, made a three to four wide run on the far turn and came six wide off the bend but flattened out. TITAN tracked the pace on the inside and rode the rail on the far turn but lacked the needed winning bid. PRINCE DAVID tracked the pace three wide and weakened. WINEMAN TRAX was allowed to settle along the inside and swung out three wide leaving the turn but had no rally. RIVER OF TIME bumped with a rival at the break, tracked the pace in between rivals but weakened.

KING D'ORO was rated along in the two path on the first turn, settled into a nice stride and saved ground on the far turn, cut the corner leaving the bend and slipped thru to be clear by the furlong marker and kicked away to prove best under right handed crop urging. MEYER was allowed to settle early and made way to the rail, saved ground on the far turn and cut the corner leaving the bend and ran on in the lane and moved out by the sixteenth marker and rallied. BAKERS STREET was five wide into the first turn, stalked the pace on the outside and made a three to four wide bid leaving the quarter pole but was out-finished while besting the rest. GLOBAL PROSPERITY was well placed early on the inside and made a two to three wide bid leaving the quarter pole to vie for command between rivals by the three sixteenth marker but faded in the final furlong. RELAMPAGO VERDE was four wide into the first turn and chased the pace three to four wide and came under a ride on the far turn, five wide into the lane but had no rally. BAY OF BENGAL showed the way while clear in the two path on the first turn, dropped to the inside on the far turn and was headed leaving the turn and weakened in the final furlong. SPACE LAUNCH was fractious in the gate, off slowly and trailed, came four wide into the lane and never threatened. HAMILTON'S WAY tracked the pace in between rivals on the first turn, then chased the pace two to three wide on the far turn but tired in the lane. MOON LANDING was fractious in the gate, settled back early and saved ground on the far turn and was not a factor.
