SWEETSTER stalked the pace in the three path, took over near the sixteenth pole and edged ahead under a drive. HAWKEYE STATE raced off the pace four and five wide and rallied through the lane to gain the place. SHIP SERVE bumped DO BETTER at the the start, set the pace in the two path and yielded near the sixteenth pole. MYKONOS chased the pace inside and lacked the needed rally. LEO'S ROCKET raced off the pace four wide and had a mild belated rally. DO BETTER was bumped at the start, raced four wide and never threatened. BABY RASTA saved ground off the pace, tipped two wide near the quarter pole and had no rally. FINDING CANDY was outrun while racing three wide.
