FAENA raced in range three wide, bid four wide around the far turn, dueled outside of JUSTICE PREVAILS through the lane, continued on the left lead in the lane, lugged in and bumped late and narrowly prevailed. JUSTICE PREVAILS stalked the pace in the three path, took the lead near the five-sixteenths pole, dueled inside of FAENA through the lane, bumped with that foe late and just missed in a game try. BOMBS AWAY set the pace in the two path, was collared near the five-sixteenths marker and held for the show. SUNFISH raced well back two wide, swung six wide near the quarter pole and passed tiring rivals. MORE APPLAUSE broke out and bumped BLUES MUSIC at the start, chased the pace three wide and faded in the lane. TOO LOOSE LA TREK was outrun inside. BLUES MUSIC was bumped at the start and never threatened while racing three and four wide. KINDA CLEVER was outrun while racing two and three wide. DEL MAR SUNRISE (IRE) was hard held while pulling inside through the opening half mile and had no response. THE STEWARDS CONDUCTED AN INQUIRY INTO THE STRETCH AND TOOK NO ACTION.
