NO VALLA tracked inside, was nudged along the rail around the far turn, waited for an opening in the two path at the top of the lane, was roused to split rivals while still in the two path passing the eighth pole, and kicked clear of the inner pacesetter in the final sixteenth. BIG BAND LUZZIANN showed the way along the inside, was pushed along around the far turn, kept on along the inside into the stretch, got caught by the winner around the sixteenth, but held place. OKAY FINE chased in the four path, came under right handed encouragement in the five path rounding the far turn, tipped out to the six path at the top of the lane, and finished evenly for show. STARRY HOPE laid in midpack from the two path, was coaxed along around the far turn, but was one paced from the five path in the stretch. MUSICAL ROMANCE (GB) trailed in the four path down the backstretch, tipped to the two path entering the far turn, fanned out to the eight path at the top of the lane, but was no factor. JUDGE JUDITH stalked in the three path, was roused into the far turn, but faded in the stretch. FOUNDER'S DAY was unhurried in the two path early but never menaced.

BOURBON WARRIOR set a clear pace in the two path and held clear under a drive. SIR BANANA BRIAN was bumped at the start and again soon after, raced off the pace two wide, angled four wide in upper stretch and rallied for the place. JAKE'S AFFECTION saved ground in range, made progress in upper stretch but flattened out a bit in the final furlong. XY FACE was bumped after the start, chased the pace three and four wide, continued on the left lead in the lane and finished evenly. ANADOLU chased the winner in the two and three paths, continued on the left lead in the lane and weakened. MISTER COOPER was knocked sideways near the nine-sixteenths marker, raced seven wide around the turn and never threatened. BERNARDO'S LEGACY broke inwardly and bumped foes at the start, raced off the pace five wide and lacked the needed rally. WALKING TESTIMONY bumped with AMAZING WOO at the start, was bumped again not long after, saved ground and was never a threat. ROYAL ABERDEEN was bumped between foes at the start, chased the pace four wide and faded. SOUTHERN CIVILITY was bumped near the nine-sixteenths marker, raced three wide and was never involved. PAISAN was

outrun inside. AMAZING WOO was bumped at the start and again about sixteenth of mile into the race, raced six wide around the turn and was through early.

KAITIE KAIT rated in the two path, angled out under a ride passing the quarter, swung from the six path into the lane, and kicked past an inner pair while on her left lead just after the eighth pole. NAUGHTY FAVORS showed the way in the three path, was cued along the inside midway around the turn, tipped out to the two path entering the stretch, was caught just after the eighth pole, but dug in to hold place. DEVIL AT MIDNIGHT prompted the pace in the four path, bid in the three path around the turn, kept on from the four path into the lane, but hung for show. MIGUEL'S BELLE stalked in the five path, was ridden in the four path around the turn, but finished evenly in the five path down the lane. MYWIFEKNOWSITALL tracked in the three path, was ridden from the four path into the turn, fanned out to the seven path at the top of the lane, but made no impact. SUGAR TREAT pressed inside but flattened in the stretch. NICKY JOLENE chased in the four path but made no impact from the six path down the lane. SPECIAL AFFAIR trailed throughout from the two to four paths.
