ROLE PLAY was away alertly and crossed over to set the pace on the inside and was well handled, drew clear leaving the turn and then maintained a safe margin to the wire under right handed crop urging. STRIKING FINALE was reserved on the inside, split rivals nearing the five sixteenths and moved out to come five wide into the lane and closed well but was too late and had to settle for being second best. JUSTICE PREVAILS bobbled a bit at the break, pressed the pace two to three wide and fell back leaving the quarter pole and weakened in the lane saving the show award. MAX was well rated early and made a four wide bid nearing the quarter pole but weakened in the drive. ZARAFSA was settled along the inside and passed the tiring rivals. GALLEGA ran off about a furlong pre race, reluctant to load, reserved early and failed to menace. GROOVY N GRAY chased the pace in between rivals and came under a ride three wide on the far turn and weakened. PEARL OF PEARL tracked the pace on the outside and then went up to prompt the pace three wide on the far turn and tired. RUNTOWN tracked the pace on the inside and tired.
