MAITRE D gained the early lead, forged clear leaving the turn and pulled away under steady pressure. SURF'S UP prompted the pace, was no match for the winner but found enough to narrowly hold the place spot. CAPTAIN EDDIE outpaced while four wide, went five wide into the stretch and finished well.

FAST FIXER off a step slowly, chased the pacesetter, moved closer on the turn and stayed on in the stretch. SCHNITTKER awkward at the start costing him a few lengths, trailed, was swung seven wide for the stretch run and managed a belated rally. VALID SENSE saved ground and failed to threaten. CARAMBASO was always outrun. AIR FORCE CRUISING raced forwardly along the inside and weakened in the stretch. READIER outrun early, entered the stretch four wide and proved no factor. CHAPLIN was outpaced while five wide and never reached contention. HOLLYWOOD MAYHEM was forwardly placed and offered no response when called upon.
