FILLIES AND MARES, FOUR YEARS OLD AND UPWARD. Free nomination by Saturday, May 2. \$625 to enter. A \$100 supplemental nomination may be made at time of entry. After payment of 1% to all owners of horses finishing sixth through last, 60% of the remaining purse shall be paid to the owner of the winner, 20% to second, 12% to third, 5% to fourth, and 3% to fifth. *(\$25,000 to the owners of a Florida-bred divided \$12,500 to the winner, \$7,500 to second, \$2,750 to third \$1,500 to fourth and \$750 to fifth). Weight: 124 lbs. Non-winners of a stakes on turf since October 1 allowed 2 lbs.; two races other than maiden, claiming, starter or state-bred allowance, 4 lbs. All fees shall be paid prior to the start of the race. Preference will be given to stakes winners, stakes placed then by highest earnings in 2025-26. (If deemed inadvisable to run this race over the turf course, it will be run on the Tapeta Course at One Mile and Seventy Yards) (Rail at 59 feet).

TURINO raced forwardly after being maneuvered off the inside rail early, lodged a three wide bid entering the stretch, responded to a drive and got up in the final strides. MISS MARY NELL forced the pace, gained a narrow advantage just past the eighth pole, dug in stubbornly but was caught. LITTLE JAMIE reserved while racing along the inside fence early, advanced between foes on the far turn and stayed on willingly in the stretch. FANTASY PERFORMER trailed early, commenced her bid on the far turn and finished well in the stretch. MAKE THE BOYS WINK saved ground, moved closer on the far turn and closed some ground in the stretch. MINTY gained a narrow early lead, was hooked on the far turn and worn down late. PUBLIC DEFENDER settled while four wide, was swung six wide into the stretch, pulled up abruptly after the wire and left the track in an equine ambulance. FLOWERS FOR ME chased the pace while four wide, advanced briefly on the far turn and came up empty in the stretch. FOLLOWING THE RACE, THE STEWARDS BRIEFLY LOOKED INTO AN INCIDENT NEAR THE FINISH AND MADE NO CHANGES.
