SULION grabbed the early lead, ceded the advantage up the backstretch run while being taken in hand, travelled well around the far turn, forged clear when given his cue in the stretch and held well thereafter under steady pressure. MALCOLM X (PER) checked hard off heels on the first turn, dropped back sharply as a result, lodged a contending bid on the far turn and finished well but could not reach the top one. GIURO pulled in the early going, advanced on the far turn and stayed on in the stretch. STARSHIP MAGELLAN ducked out at the start hampering a pair of rivals, settled well while four wide, moved five wide into the lane and kept on without posting a threat. FROSTED PUNK stalked the pace, went five wide into the stretch and came up empty. ANTONINO was always outrun. SARATOGA CRUISER was knocked sideways at the start and outpaced while five wide. VIN NUMBER bothered at the start, was angled in early and proved no factor. SPONGE TIME forwardly placed, assumed command at the five-eighths marker, was headed turning for home and faltered.
