ANSWER THE CALL prompted the pace two wide and made a three wide bid to go on even terms leaving the quarter pole, came four wide off the turn and went clear and drew out to prove best under a drive. MUSICAL JOURNEY was allowed to settle early, advanced two to three wide on the far turn, angled in leaving the three sixteenths and was up for the place award. MIA'S ANGEL was allowed to settle and moved to the inside, saved ground on the far turn and came two wide into the lane and finished well missing the place award. THREEDOTS ANDADASH was reserved early, and raced on the inside to the two path and had a mild late rally. MAMUKA was settled back early, made a four wide run on the far turn but needed more late. JUDGE JUDITH set the pace and moved to the inside on the first turn, headed leaving the quarter pole and came three wide off the turn and came up empty in the final furlong. STRAND OF GOLD was settled early and raced three wide and tired. BRENNNA was settled early and had outside pursuit and raced four to five wide on the far turn and tired.
