FILLIES, THREE YEARS OLD. Free nomination by Saturday, May 23. \$625 to enter. A \$100 supplemental nomination fee may be made at time of entry. After payment of 1% to all owners of horses finishing sixth through last, 60% of the remaining purse shall be paid to the owner of the winner, 20% to second, 12% to third, 5% to fourth, and 3% to fifth. \*(\$25,000 to the owners of a Florida-bred divided \$12,500 to the winner, \$7,500 to second, \$2,750 to third \$1,500 to fourth and \$750 to fifth). Weight: 124 lbs. Non-winners of a stake race since December 1 allowed 2 lbs.; two races other than maiden, claiming, or starter, 4 lbs. Starters to be named by usual time of closing. All fees shall be paid prior to the start of the race. Preference will be given to stakes winners, stakes placed then by highest career earnings.

HAUTE DIVA broke a step slow, lacked speed, swept up into a contending position four wide through the second turn, dueled final furlong outside, proved narrowly best in a game effort. MIA FAMILIA tracked the pace while toward the inside, continued forwardly into the far turn, moved out and advanced to challenge three wide and inside the winner turning for home, dueled with that one the final furlong, outfinished. BAYOU BRIGID within striking distance while three wide, fell back off the issue in the second turn, came back to earn the show late without threatening the top pair. R SLEW OF CASH moved out when closest to the leader into the turn, prompted that one the middle half mile, moved to engage that same rival late in the final turn from the outside, briefly put a head in front between calls entering the stretch then yielded to the top two soon after, continued to weaken and was caught late for the show. NYFIVE broke well from the outside, showed the way into the first turn, shook clear before a quarter, set the pace in the two path, weakened when headed entering the stretch. CAURA off a step slow with the winner, raced back off the pace and the inside, lacked a closing response. MISS T BOBO back off the pace and the inside, asked along in the far turn three wide, failed to respond and trailed home.
