MALCOLM X (PER) settled off the early going, made a good rail bid through the stretch run and finished well to be clear under a steady hand ride. MEGACLES rated along racing under a snug hold, made a three wide bid in the drive and finished gamely to the wire. ONE MORE DUKE set all the pace from the outside and weakened a bit the final eighth of a mile. MISTER MONOCLONAL stalked the pace, had an inside run, aim through the upper stretch and had no final winning bid. After the wire Mister Monoclonal collapsed after the wire and was loaded into the equine ambulance. GANADOR dropped back to race mid pack, four wide into the upper stretch and needed more. GIURO void of early speed, saved ground, in tight quarter pole from the inside through

the upper stretch and had no late gain. DAVID PEPPERMAN prompt the early leader three wide from the outside and gave way. SPIRIT OF THE LAW failed to respond. RASKOLNIKOV saved ground and never menaced.
