WORLD TRAVELER stalked the pace, made a three wide bid near the quarter pole, drifted through the stretch, forcing Amelia out, a stewards inquiry and jockey objection from Ameelia filed against World Traveler and stewards deemed World Treller placed second for interference through the stretch run. AMELIA settled early on to race off the early pace, was four wide both turns, forced out through the stretch run and finished gamely to the wire. ANSWER THE CALL set a pressured early pace along the inside and weakened a bit in the final stages. MIA'S ANGEL dropped back early, moved up four wide into the upper stretch but needed more in the drive. TOUR QUEEN trailed early on, hard ridden four to five wide through the far turn, raced widest through the lane and never threatened. FULLY ENTITLED prompt the early leader from the outside and faded. JUDGE JUDITH was off very slow, lost a considerable amount of ground at the start, saved ground and raced far back while never threatening.
