TEAM OF RIVALDS settled well while four wide, lodged a bid around the far turn, continued four wide into the stretch, responded to his cue and surged clear in the stretch. SENOR ROBERTO off a step slowly, commenced a bid on the far turn and produced a four wide rally in the stretch. CASH BONUS raced forwardly along the inside rail, was maneuvered off the rail into the stretch and offered a three wide bid. PAX MUNDI off a step slowly, was outpaced while three wide, advanced on the far turn and managed a mild five wide bid. CIBORIO was settled while three wide and stayed on without posing a threat. SIR GUINNESS was forwardly placed behind the pacesetter and gave no response when asked. THUNDER ZEUS raced in striking position while three wide, took a narrow lead on the far turn and came up empty in the stretch. TWIRLING was reserved along the inside and always outrun. FOUR COURTS set a contested pace, was challenged on the far turn and gave way.
