GETAHOLDAYOURSELF stalked the pacesetter, took over approaching the quarter pole, bore out six paths in the stretch under left-handed pressure, bothered ZARAFa but crossed the finish line in front. ZARAFa reserved early, commenced a bid around the far turn, kept on under pressure, was carried out nine wide in the final eighth, checked at the sixteenth pole as a result and still finished well. BASILICA LIGHT broke through the gate, was immediately grabbed by an assistant starter, gained the early lead, was headed on the far turn but kept on to claim a minor share COUSIN PAMMIE ducked out at the start, bobbed soon after, was outrun early, moved five wide into the stretch and managed a mild rally. GHOSTS LIL SECRET off slowly, saved ground, was angled out up the backstretch run, inched closer while wide on the far turn and stayed on in the stretch. DECISIVE MAIARA chased the pacesetter, moved four wide into the stretch and offered no response. GALLANT RUNNER had a wide trip and did not menace. FOLLOWING THE RACE, THERE WAS BOTH A STEWARD'S INQUIRY AND RIDER'S CLAIM OF FOUL INTO THE STRETCH RUN. AFTER REVIEWING VIDEOTAPED REPLAYS, THE STEWARDS DISQUALIFIED GETAHOLDA YOURSELF FOR INTERFERENCE AND ZARAFa INHERITED THE VICTORY.
