THE PACKAGE settled off of the contested early pace, shifted to the rail approaching the turn, mounted an inside bid nearing the quarter marker, took command into the stretch, dug in at the furlong grounds, kept to task to the final sixteenth and proved best late. LITTLE TOWN STREET prominent early while three wide and between runners, caught in tight between foes into the turn then lost ground nearing the quarter marker, shifted to the four path to upper stretch, re-bid willingly into the lane, couldn't reel in the winner in deep stretch but was up in time for the place. ZEALOT close up to the early pace while four wide, loomed along the turn then vied for the lead nearing the quarter pole, battled three wide to upper stretch, was outkicked by THE PACKAGE to the final sixteenth and overtaken in the final strides for the place, while holding for the show. MY PERFECT LADY took early command, set the pace from inside of a trio of rivals heading to the turn, led from the two path nearing the quarter pole, overtaken by THE PACKAGE to upper stretch, chased the winner to the final sixteenth, faded late. MO HIJINX prominent in the early stages while between rivals, was caught in tight and shuffled back into the turn, chased into the stretch but could not mount a late response. SWEET SASH bobbled and broke out at the start and last away from the gate, settled while saving ground early on, caught in tight and steadied approaching the turn, swung to the five path to upper stretch then did not threaten in the late stages. ELLAGIO unhurried early, shifted out and was coaxed three wide into the turn, swung to the six path to upper stretch then did not factor the drive.

QUEEN KWAINA broke out and crowded an outer rival, settled off of the early pace then saved ground into the turn, ran in pursuit of HAPPY FEET HANNAH to upper stretch then tipped to the outside of that foe entering the final furlong, closed determinedly to the final sixteenth, wore down the game runner-up in deep stretch and was up in time to prevail. HAPPY FEET HANNAH away in good order and took early command, set a contested pace to the turn, dictated terms to the quarter marker and kicked clear to upper stretch, dug in at the furlong pole, drifted out while under firm left handed urging into the final sixteenth, fought gamely to the wire but was bested in the final strides and was well clear of the rest for the place. KIONA bobbed at the start then crowded an outer foe leaving the gate but was away in good order, went up to press the early pace from outside of HAPPY FEET HANNAH, kept close attendance to the pacesetter into the turn then lost ground nearing the quarter marker, gave chase into the stretch, was no match late for the top pair but held safely in the end for show. NIPSEY hopped then crowded at the start and was last away from the gate, unhurried along the backstretch, improved position into the turn, coaxed from the two path to upper stretch, made a mild late rally but needed more in the final stages. CURLINA STAR crowded by inner rivals at the start but away in good order, settled while widest along the backstretch, coaxed four wide to the quarter marker, spun to the five path to upper stretch and lacked a late rally. SMART LISA broke out at the start, settled while saving ground early on, kept an inside path to the turn then trailed passing the three-eighths pole, was last nearing the top of the lane and passed a tiring rival in the stretch. THE TWINS stumbled and crowded at the start, settled mid-pack in the early going, went up to track the leading pair heading into the turn, couldn't keep pace while three wide nearing the quarter pole, tired and was not persevered with in the stretch.

BALL UP TOP a bit slow away from the gate, settled outside of rivals early then tracked the leading pair approaching the turn, coaxed two wide to the quarter pole, swung three then four wide for the stretch drive and responded well into the final furlong, took a narrow lead in the final sixteenth then dug in into deep stretch to prevail. UNCAPTURED DOVE raced close up while saving ground, tracked the leading pair from the inside heading into the turn, lacked room to upper stretch, split foes at the furlong grounds, rallied along the rail to deep stretch but came up just short at the wire. ZOLENE rushed up to press the early pace, disputed solid fractions nearing the quarter marker, vied into upper stretch then dueled to the furlong pole, fought gamely to the final sixteenth but could not find more in deep stretch and was outfinished for the win and place, while holding clearly for the show. BREEZEY Z broke alertly and took early command, showed good speed along the backstretch then was pressured into the turn, set a solid pace to the quarter marker, dug in while under pressure into upper stretch, couldn't find more into the final furlong then faded in the final sixteenth. TIE IT WITH A BOW in tight and steadied between rivals soon after the start, settled to the turn then trailed nearing the quarter pole, chased from the inside into the lane, shifted out for the final sixteenth but lacked a late response.

MAJESTIC DELIGHT close up to the early pace while inside of rivals, was caught in tight into the first turn then took back and tracked from the second flight into the backstretch, well placed to the half-mile, chased to the quarter pole then mounted a three wide bid into the stretch, responded well into the final furlong, wore down the game runner-up in deep stretch and got up in the final strides to prevail. APACHE ONE SIX forwardly placed early, raced close up while four wide to the first turn, prompted the decent pace into the backstretch and vied for the lead into the far turn, dueling MARC KENTUCKY (ARG) into the lane then led into the final sixteenth, dug in to deep stretch but was nailed for the win in the final strides and was well clear in the end for the place. MARC KENTUCKY (ARG) broke in at the start, vied for the early lead from between foes, took command and set the pace to the backstretch, dictated terms off of the rail nearing the half-mile pole, came under pressure into the far turn and met the bid of APACHE ONE SIX to upper stretch, was turned away then yielded to the top pair into the final sixteenth and was a well clear third. SKYLINER jostled then squeezed back at the start, settled to the first turn then raced outside of rivals along the backstretch, ran in pursuit three wide to the quarter pole, swung widest into the lane, offered a mild late bid but did not impact the leaders in the final stages. CASE LAW was away in good order then settled to the first turn, raced in mid-pack to the half-mile marker, coaxed two wide into the far turn, ran in pursuit of the leaders into upper stretch, couldn't muster a rally to the furlong grounds then weakened. WORKINCLASSKID bumped between rivals at the start then settled to the first turn, saved ground along the backstretch run, got caught in traffic entering the far turn, angled out then

was asked for run three wide to the stretch, lacked a response at mid-stretch and did not threaten late. FLAMEFIRE off slow and void of early speed, trailed to the second turn and passed a tiring rival in the stretch. BRAVENESS sent to vie for the early lead, rated into the first turn then was well placed while saving ground to the backstretch, lost ground into the far turn and came up empty in the stretch drive.
