GIVE ME OPTIONS settled outside, tracked two to three wide to the half-mile, bid three wide to upper stretch, edged away in the final sixteenth and proved best. FLAMEFIRE settled to the backstretch, gained ground four wide to the quarter marker, swung five wide to upper stretch, chased the winner late and held for second. KISSINTHELADIES vied for the early lead then ceded to ROCKY LAGOON, tracked the pace while off of the rail heading into the far turn, got caught in traffic into upper stretch, needed more to the final sixteenth and just missed for second, while holding safely for third. AMBERSSOHN settled in the second flight early on then was caught a bit in tight between foes into the first turn, saved ground along the backstretch run, encountered traffic nearing the quarter marker, found a seam to upper stretch then gained at the furlong marker, caught a bit in tight while along the fence into the final sixteenth and lacked a late response. NUMINOUS vied for the early lead, took back and tracked the pace two to three wide along the backstretch, gave chase two to three wide to the quarter pole, gave way stretch. ROCKY LAGOON raced in the second flight leaving the gate, made an early move between foes into the first turn and took command, set the pace to the quarter marker, overtaken to upper stretch and faded in the drive.
