SIR GAR D'LYON bobbled then squeezed at the start then trailed early, made a sustained rally along the inside, proved best. DOMINICAN PIRATE bothered at the start, gained ground into the turn, asked three wide to the stretch, closed willingly to the final sixteenth, couldn't reel in the winner late but was up in time for the place. ACTION DELIGHT stalked the early pace from the outside, vied four wide into the turn then took command nearing the quarter marker, led into the stretch then dug in at the furlong grounds, couldn't hold off the winner into the final sixteenth then was outfinished for the place, while clear of the rest for the show. CADENCED forwardly placed early on, went up to press the pace from the inside heading into the turn, couldn't keep pace at mid-stretch then yielded in the late stages. FRIDAY NIGHT LIGHT rushed up to vie between runners along the backstretch, disputed the pace two wide and between rivals into the turn, turned away into upper stretch then weakened in the lane. REPROCHE veered in at the start and bothered inner rivals, settled along the backstretch, trailed nearing the quarter marker, stayed on while saving ground into the stretch and passed tiring rivals. AWEGOD away in good order and contested the early pace with ACTION DELIGHT, took command and set the pace from the three path heading to the turn, lost ground nearing the quarter marker, swung to the four path to upper stretch and gave way in the drive. STAN THEMAN MUSIAL chased the early pace from between foes, lost ground two to three wide nearing the quarter marker, couldn't find more into the stretch and tired. EXPERT WITNESS tracked the early pace while widest along the backstretch, ran in pursuit three to four wide nearing the quarter marker, lacked the needed response to upper stretch then came up empty in the

drive.
