SNEAK PREVIEW chased the pace while four wide, was urged to improve his position on the turn, lodged a four wide bid in the stretch, took aim and was up in the last jump. LOU THE BODY seized command early, bounded clear on the turn, remained clear in the stretch but was nailed on the wire. AWESOME TRAIN outpaced early, commenced his bid on the turn and stayed on while five wide in the stretch. GIVE ME LIBERTY stalked, was outpaced leaving the turn and came up empty in the stretch. ACCELERATE ME broke slowly and was outrun while five wide. MANOR HOUSE was forwardly along the inside fence, offered no response when asked and dropped back.
