## Footnotes | View Glossary Of Terms

BLAST RADIUS showed speed and assumed early command, shook free into the turn the kicked clear to mid-stretch, dug in into the final sixteenth and held for the win. KEEP ON MOVING broke through gate prior to the start, took back off of the early pace and was well placed to the turn, chased from the inside into upper stretch, drifted out into the final sixteenth, surged in deep stretch and just missed for the win, while besting the rest. EXPECT THE BEST settled, gained three wide at the quarter pole, chased four wide to the stretch, was carried out late but finished well to earn the show honors. NOTHINGSUBTLE chased three wide, battled to mid-stretch, was carried out by a drifting rival into the final sixteenth and was outfinished for third. MIAMI FRANK tracked outside, chased four wide upper stretch, carried out in the final sixteenth and needed more in the late stages. RAGING FURY settled inside, shifted out nearing the quarter marker, ran in pursuit into the stretch then was caught in traffic nearing the final sixteenth, drifted out in deep stretch and made a mild late rally. TEOFIMO squeezed start, swung five wide to upper stretch, steadied to avoid traffic in the final sixteenth. LASSO tracked inside, well placed to the turn, weakened. TICKING raced between foes to turn, shuffled back into the bend, swung widest for the stretch drive and tired. THERE WAS A STEWARDS' INQUIRY INTO THE STRETCH RUN OF THIS RACE. IN ADDTION, THE TRAINER OF NOTHINGSUBTLE LODGED AN OBJECTION AGAINST KEEP ON MOVING, CLAIMING INTERFERENCE IN THE FINAL FURLONG. THE STEWARDS RULED THERE WOULD BE NO CHANGE.
