## Footnotes | View Glossary Of Terms

SIGAN VIENDO pressed the early pace from the inside into backstretch, lost position into the far turn, re-bid three wide nearing the furlong marker, responded late and determinedly was up in time. DIMANCHE GRAS settled early, bid six wide to stretch, finished well, up for second. DIME PAPI off slow, settled then was boxed in at the quarter pole, bid five wide and between foes at mid-stretch, battled to the final sixteenth and was clear for third in a good effort. OUTTA MONEY tracked to far turn, vied three wide upper stretch, outkicked late. CORTA FUEGO well placed to backstretch, bid into the far turn then vied two wide to mid-stretch, yielded late. GIFTEDBYDESIGN settled early, blocked from the far turn to upper stretch, angled out at the furlong grounds and was outkicked in the final sixteenth. RASHID set pace from the two path then to the inside, faded final furlong. SNEAKY SNEAKY shuffled into first turn, bid four wide second turn, weakened. THE JOCKEY OF OUTTA MONEY LODGED AN OBJECTION AGAINST THE JOCKEY OF SIGAN VIENDO, CLAIMING INTERFERENCE AT THE START AND IN THE FINAL FURLONG. THE STEWARDS DISALLOWED THAT OBJECTION AND RULED THERE WOULD BE NO CHANGE.
