BOLD ADVANCE vied for the lead on the inside to the turn, shifted out around the turn and made a late surge to be up in the final jump. MAJOR KING took the lead going onto the main track while being pressured by BOLD ADVANCE to the turn then pulled away around the turn but was challenged in the final yards and was denied. MR SCATTER was unhurried while racing wide down the backstretch then made a mild bid on the turn but was no match for the top two. BOLD LOOKER was allowed to settle while racing three wide, dropped back on the turn and was never a factor.
