ROGER THAT DANA set the pace under early pressure, edged away on the turn, responded when called upon for the drive and finished well to hold the runner-up safe. TEOFIMO raced mid-pack just off the four way early pace battle, closed the gap with a steady advance to move to striking distance, continued to close ground while unable to reel-in the winner and pull away from the balance of the field as second best. SPIRIT OF THE LAW slow early to be the trailer, rallied turning for home with late interest to be along for the show. RASKOLNIKOV tracked the leader following the move of the runner-up and failed to sustain the bid lacking a closing kick. TYBEE ECHO pressed the pace for a half mile and steadily faded from contention. TAPARINO was one-paced failing to menace. I'M TUFF ENOUGH chased the early pace down the backside and was through early. ACTION DELIGHT was prominently placed early and faded from contention.
