CODE THREE prompted the pace in the two path, was cued midway around the turn, bid for the lead passing the quarter, held a narrow advantage at the top of the lane, and inched ahead. MORE POWER TO YOU showed the way along the inside, waited around the turn before coming under pressure going by the quarter, lost the lead to an outer rival in upper stretch, but kicked on to hold place. DR. D'ORO tracked the top two, received a right handed cue in the two path passing the quarter, and kept on in the four path down the lane to clearly be best of the rest. TY WEBB was pushed along from off the pace, continued under coaxing from the three path around the turn, but lacked a closing kick. ABARRIO FUGAZ steadied along the rail just after the start, remained along the rail while trailing around the turn and never threatened. POOLKILLERS chased along the rail early but retreated.
