## Footnotes | View Glossary Of Terms

VINDICATE CHA CHA set the early pace and was clear while racing in the two path on the turn, came three wide off the bend and sent down nearing the furlong marker and kept clear to the wire to prove best while being kept to task. CALL ME SPICY was allowed to settle early, advanced two to five wide on the turn, came six wide off the bend and finished well to gain the place award. ROYALLY BLUE brushed with a rival at the break and reserved along the inside, put to coaxing on the turn and eased off the rail and swung out seven wide leaving the turn and had a belated rally to gain the show award on the wire. BEAUTIFUL CRAZY tracked the pace along the inside but lacked the needed winning bid and lost the show award on the wire. TRAVEL HAPPY stalked the winner from between rivals and three wide on the turn but weakened in the lane. SOPHISTRY brushed at the break, angled out by the half mile marker and back in, then chased the pace on the inside on the turn but faded. ALAS DORADAS tracked the pace from the outside and was three to four wide on the turn and weakened. MOLLY'S A BULLET was reserved early and three wide on the turn but lacked a rally.
